1. Call to order

President Ken Gilbert called the meeting to order at 5:32pm

2. Approval of May 2, 2020 Board Meeting Minutes

Harvey motioned to approve as updated, Walt seconded. Approved 5-0.

3. Owners Forum

4. Financial Report

• Harvey discussed the ongoing \$6k remaining debt involving a prior owner of of unit 51 (around 2008). Cindy Butner suggested writing it off, since it makes it easier for Butner HOA Services to transition to the new bank. Writing it off does not prevent us from further pursuit in the future if we decide to do so. We have filed some claims without success. The board unanimously agreed to write off this bad debt that we haven't been able to collect on since 2008.

5. Manager's Report

- Cheryl: Tennis court is finished using new repair product. We'll see how it goes over the winter. Earthquakes during the last month have made some of the center court cracks more significant. Pool was opened last Friday. Jacuzzi and Sauna remains closed (per county order). Ken questioned whether there was a difference between public and private pools and saunas. HOA association pools are considered public; Mono county web site has details. Pools have additional cleaning requirements, checking requirements to make sure social distancing is being adhered to.
- Gary: Had a guy out looking at gutters to prevent black ice formation on various walkways. This involves 4 of the 8 unit buildings, e.g. near unit 53. This also involves some electrician work to provide electricity for the heat tape that is used in the gutter. Black Gold is pricing some tennis court repair, using a similar approach as they did with Wildflower, a nearby condo. Also looking into Line 2, an application suggested by Ken to enable a second cell phone number. Office has a glass barrier to facilitate Covid safety.

6. Election Plans

- Process any Final Comments and Approve 2020 Election Rules
 - Ed motioned to approve the rules as specified, subject to a 2 person committee handling the unlikely event of additional comments in the remaining 2 days of the comment period. Walt seconded. Approved 5-0. Ed and Tom will comprise the two person committee. When the

- comment period ends on June 17, we will post the new rules and call for nominations on the web site, send to owners via e-mail, and send to Butner to provide a copy by mail.
- ➤ Ken asked about the election inspection process. Harvey asked for a quote from an outfit that Ken had mentioned but after 3 weeks they have not responded. Harvey then asked Cindy Butner for some local suggestions, and she responded with someone named Craig Hansen, a former owner of Mammoth Business Essentials, who she knows has done this for a couple of condos in town. He's a notary public, which qualifies him to do this. So far we don't have a clear idea of the cost
